Call Meeting to Order

Commissioner Detzel called the meeting to order at 7:01 p.m. In attendance were Commissioners Detzel, Ragen, Schneider, Shewmaker and Kressel. Also in attendance were Chief Rewis, Attorney Pringle, Administrative Assistant Howard, Deputy Chief Lamb, Tim Jones from Local 1826, Alva Fire Department Commissioners Crittenden and Fichter, and Alva FD Engineer Etchevery.

Pledge of Allegiance and Moment of Silence

Review of Budget Process and the Budget Draft – Attorney Pringle reviewed the budget process and Chief Rewis reviewed the proposed budget. The total budget has not changed since the tentative budget was approved earlier in the month. There was also discussion about how the rolled-back rate is calculated and what it means with the application of homestead exemption prior to calculating our ad valorem levy. Lee County was the only remaining county in the state which levied ad valorem for the fire districts and mosquito control prior to applying homestead exemptions.

Announcement of the percentage increase from the rolled-back rate:

- a. Rolled-back rate is 2.118 (\$ 2.118 per \$1,000 of taxable value)
- b. Proposed rate is 2.5000 (\$ 2.50 per \$1,000 of taxable value), which is an increase of 13.03 % from the rolled-back rate.
