 After some discussion Commissioner Schneider made a motion to approve the CBA on condition of the Union's approval and authorize the Chair to sign after the Union has signed.
 Commissioner Shewmaker seconded, and the motion passed.
- Approval of the renewal of the group cancer policy with United Badges. There was discussion of the available plans and options.
 - Commissioner Schneider made a motion to approve the renewal of the United Badges cancer policy with the option of coverage of recurrence or second cancer diagnosis for a total of \$6,411.50. Commissioner Ragen seconded, and the motion passed.

<u>Public Input on Non-Agenda Items:</u> Attorney Pringle, as a resident of the district, commented that he is very happy to hear about the progress we are making in getting paramedics certified and working toward an ALS program.
