- I received a letter of intent to negotiate from the Union Districts 18 and 20 and have provided some dates for their review. I am waiting for a response from them to schedule negotiations.

 The radio equipment has been installed on the new rescue truck. Once the manufacturer's training is complete and we complete our EVOC (Emergency Vehicles Operators Course) training, the unit will be ready to go into service.
